AWARDS: \$1200 in cash prizes, plus merchandise awards

ELIGIBLE WORK: This show is open to all women artists regardless of place of residence. Original work in oil, watercolor, pastel, acrylic, mixed media, collage, graphics, photography, sculpture. Photomechanical reproductions of original work (giclee prints) are not eligible.

SUBMISSIONS: All work will be judged by electronic images in .jpg format submitted on CD. File name of each image should include the title, size and medium of the work (i.e. Portrait of Katie Oil on Canvas 24 x 30) with no punctuation or special characters. Work must be suitably framed and wired for hanging. No complex installations or clip frames. Two-dimensional work must not exceed 55" in any dimension. Sculpture must include a well-balanced pedestal and weigh less than 80 lbs. No accepted work may be removed prior to the show's conclusion. All work must be picked up on the dates indicated.

SHIPPING OF ACCEPTED WORK: For accepted works that cannot be delivered in person, accepted artists will receive complete shipping instructions.

Note: *The Show Committee reserves the right to disallow the exhibition of any work which, in the opinion of the Committee, is considered detrimental to the good public image of the show and its sponsors, which is too fragile to handle, or which is not accurately represented by the slide submitted.*

ENTRY FEES:

CWA Members – First entry free, additional entries \$15 each
(Members must have paid their 2009 dues in full)
Non-Members – First entry \$25, additional entries \$10 each

MEMBERSHIP: Women artists residing in Connecticut are eligible for membership after acceptance in two CWA Open Juried Exhibitions or by portfolio review.

ABOUT THE JUROR: Claudia Seymour is an internationally acclaimed artist and president of the Salmagundi Club, one of the oldest and most prestigious art associations in the country with their home gallery on Fifth Avenue in New York City.
